

## WASHINGTON COUNTY RESALE POLICY

Neither the employees of the Treasurer Office or the Treasurer are able to give legal advice. This document is merely intend to provide information before you bid on a property at Resale

- ❖ This is a buyer beware sale – it is recommended you do the research to see if there are any liens (OTC, IRS, OHCA, Mortgages, etc.....)
- ❖ The Resale is governed by Oklahoma Statutes Title 68. It is always the 2<sup>nd</sup> Monday in June at 9:00 am.
- ❖ Effective for the Resale of June 12, 2017 bidders will NO LONGER BE PERMITTED TO LEAVE THE SALE to get the money for the bids. Property will be sold to the highest competitive bidder. Payment for your bids will be expected as soon as you are declared the highest bidder on a property. You will receive a receipt at that time.
- ❖ Payments of Bids: For Certified Funds (Cashier check and money orders) the money must be deposited at the Treasurers' Office no later than 10 business days prior to the sale. If you have not made deposit at the Treasurers' Office then CASH ON HAND will be required for your bid.
- ❖ You must register prior to bidding. Registration can be completed at the Treasurers' Office starting 10 business days prior to the sale or between 8am-8:59am the day of the sale in the Administration building auction location.
- ❖ The property owner or lien holder has until 9:00 am the morning of the Resale to pay the taxes to keep the property from being sold.
- ❖ Due diligence has been practice to the best of our ability. All owners, lien holders and any persons with known interest in the properties were notified by certified mail and by legal publication in the Examiner Enterprise prior to the date of the sale.
- ❖ We suggest you quiet the title on properties that you purchase at Resale. This is a legal process through District Court. An attorney can give you more information about this process.
- ❖ The property is sold "as is" condition without any warranties of title insurance, either expressed or implied as to the nature, condition or description of the property.
- ❖ Title is transferred by Treasurers Deed within 30 days of the sale. In our county those are issued and filed the same week of the sale. We do not issue titles to Mobile Homes.
