Attached are the 3 versions of the "Affidavit of Land or Mineral Ownership" required to be filed at the time of filing your Resale Deed. The versions include: (1) for individuals; (2) for "non-exempt" businesses and trust (U.S. citizen or Oklahoma resident business owners unable - or unwilling - to certify as to the federally legal commercial operations requirement); and (3) for "exempt" businesses and trusts (those engaged in federally legal commerce). Each individual will need to fill out a separate affidavit. In order to save time, or if you are sending a representative on your behalf, you can choose the appropriate affidavit, fill it out and sign it in front of a notary prior to the date of the sale and bring the original with you to the sale or send it with your representative.
