Commissioner's Sale Procedures
O.S. 68 § 3135

1. To begin proceedings, the Bidder will need to complete and sign a bid sheet. A deposit of the starting bid amount plus \$185.00 (estimated publication costs and fees) are required in the form of **Certified Funds**. The County Treasurer will discuss and inform the County Commissioners of the bid being made for approval.
2. If the County Commissioners approve the starting bid, the County Treasurer's Office will then determine the date of sale. Commissioner's Sales are usually held on Monday mornings at 9:00 am in the County Treasurer's Office. The Bidder will then receive a phone call with the sale date and time as the Bidder will need to be present the morning of the sale. All Bidders must be registered by 8:45 a.m. in the office of the Canadian County Treasurer on sale day to bid on properties.
3. The sale Ad will run for three (3) consecutive Wednesdays in the legal section of the closest town's newspaper prior to the date of sale.
4. Upon approval from the County Commissioner's, the County Treasurer's Office will prepare and issue a deed to the highest Bidder. The deed can be picked up at the County Treasurer's Office upon completion or will be mailed to you.

Any overpayment (leftover amount) of the cost of publication and fees will be refunded to the original Bidder. All costs and fees will be charged to the highest bidder and refunded to the original bidder.

****It is your responsibility to do the research on the property for all liens levied against it.** It is suggested to have a quiet title filed with the county clerk.
