EXCESS FUNDS POLICY

As a matter of policy, adopted by the Garvin County Treasurer, using due diligence, our office has attempted to mail a notification to the record owner of record at the address or addresses that we could find, notifying that these funds can be claimed without any charges or fees.

The excess funds list will be posted on our website when it becomes available. The excess funds are held in a separate fund for the record owner of such land, as shown by the county records as of the date said county resale begins, to be withdrawn any time within one (1) year. No assignment of this right to excess proceeds shall be valid which occurs on or after the date on which said county resale began. At the end of one (1) year, if such money has not been withdrawn or collected from the county, it shall be credited to the county resale property fund.

The Unclaimed Excess Funds List is designed for the Record Owner(s) to claim his/her/their excess funds. If you are not the record owner, but the owner is living and you are the guardian of the owner, you will need an original or certified copy of the court order naming you as guardian and it must pass inspection of our legal counsel in order for anyone other than the owner to claim the funds. If the owner is deceased, you will need a court order to claim the funds. We must have the original order or a certified copy of the court order and it must pass inspection of our legal counsel before excess funds are released to anyone other than the record owner. Affidavits of Heirship, Death Certificates, Birth Certificates, etc. are not sufficient to claim these funds.

If the property was in more than one name (wife and husband), we require both parties to complete the forms. The excess funds will be released with both parties' names listed on the check as shown on the county records. A clear copy of photo ID must be submitted with paperwork to claim excess funds. This must include the photo ID of the agent assisting in claiming funds for property owner.
